### Website/Scorecards:

### Scorecards & Stats:

- Dave advised he will print the scorecards and update stats for league games going forward

Playoffs:

- Men's Playoff Format – Dave motioned 3 divisions of 8 teams format – there was no 2<sup>nd</sup>.
- Spencer motioned playoff format of 1 division of 16 and one of 8 – there was no 2<sup>nd</sup>.
- James motioned 4 divisions for the playoff format, leaving it the same as always, Mel 2<sup>nd</sup> – motion carried
- James motioned no re-seeding for playoffs, Dave 2<sup>nd</sup> – motion carried
- Women's Playoffs, Mel motioned to keep 3 divisions, James 2<sup>nd</sup> – motion carried

League Team Structure:

- There is apparently a 2007 rule book. We need to get a rules committee developed and they can then go through the rule book to see if we need to amend any rule interpretations.
